

## **RESOLUTION NO. BPC2010-001**

## A RESOLUTION OF THE GALLATIN COUNTY BOARD OF PARK COMMISSIONERS ESTABLISHING RULES FOR THE DINOSAUR PLAYGROUND

THIS RESOLUTION was introduced by the Board of Park Commissioners, moved by	
Commissioner <u>Fink</u> , and seconded by Commissioner <u>Walton</u> . This resolution was	
adopted <u>unanimously</u> .	

WHEREAS, on October 5, 2004, the Gallatin County Commissioners, pursuant to Mont. Code Ann. § 7-16-2301 *et. seq.*, created a Board of Park Commissioners (Resolution No. 2004-130); and

WHEREAS, the Board of Park Commissioners manages and oversees all county parkland within Gallatin County; and

WHEREAS, Mont. Code Ann. § 7-16-2322(i) provides that the Board of Park Commissioners may make rules to protect and promote the improvement of land and facilities under the care and control of the board, and

WHEREAS, Mont. Code Ann. § 7-16-2322(ii) provides that the Board of Park Commissioners may make rules for the use of the land and facilities by the public; and

WHEREAS, Mont. Code Ann. § 7-16-2322(iii) provides that the Board of Park Commissioners may provide penalties for the violations of park rules; and

 THE OUTSIDE SURFACES OF EQUIPMENT, FENCES, HANDRAILS, AND SHINGLED ROOFS ARE NOT FOR CLIMBING

THE TOT LOT IS FOR CHILDREN 5 AND UNDER WITH ADULT SUPERVISION

- THE TOT LOT CHAIR SWING IS FOR CHILDREN WITH DISABILITIES
- DOGS MUST STAY OUTSIDE THE PLAYGROUND FENCE
- KEEP BIKES, BIKE HELMETS, AND SKATEBOARDS OUT OF THE PLAYGROUND
- PLEASE DO NOT PUSH, SHOVE, OR RUN
- PLEASE WEAR SHOES AND AVOID WEARING CLOTHING THAT IS LOOSE OR HAS HOOD STRINGS THAT CAN CATCH ON EQUIPMENT
- IF YOU MAKE A MESS OR CREATE LITTER PLEASE CLEAN IT UP
- SHARE THE EQUIPMENT AND BE COURTEOUS TO OTHERS
- WATCH OUT FOR CHILDREN PLAYING NEAR SWINGS TO AVOID COLLISIONS
- PROTECT AND HONOR DONATED ARTWORK—PLEASE DO NOT DEFACE
- IF YOU SEE UNSAFE BEHAVIOR OR CONDITIONS REPORT IT TO THE COUNTY PARKS AND OPENSPACE OFFICE (406-582-3178)
- HAVE FUN, RESPECT THE PLAYGROUND, AND PLAY SAFE
