Shall the Board of Trustees of K-12 School District No. 72 (Big Sky), Gallatin County, Montana (the "District"), be authorized to impose a building reserve levy of 6.258 mills per year to raise approximately \$168,000 per year for five years, for a total amount of approximately \$840,000, for the purpose of providing funds to pay or secure a loan or a bond to finance the costs of various improvements to the school campus, including the new school complex, to include construction of a trash enclosure; purchase and installation of gym equipment; upgrades to locker rooms, laundry facilities and physical education facilities; enhancing the school telephone system; purchase and installation of fiber optic intranet cable; landscaping; outdoor classroom site work and outdoor classroom equipment; and purchase and installation of fixtures, furnishings and equipment; and paying any incidental costs associated with securing such a loan or a bond?

If this building reserve levy proposition passes, it is estimated that, using current assessed values of taxable property in the District, property taxes on a home valued at \$100,000 will increase by approximately \$8.19 and on a home valued at \$200,000 will increase by approximately \$16.38.

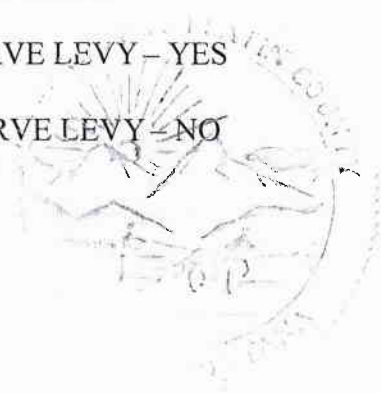
