- **Strategic Planning-** Erin Taylor and Nicole Madden changed some of the Strategic Plan. Erin asked the group; how does the information get into the group and how does it get out- this is an advisory council, and we need to figure out how to get the information shared in these meetings out to the community. The group need to have a real tactic as to how we get our information and take some ownership of it. We need to be looking for various ways of collection and disseminating information

- **Marijuana Tax Funding Ideas- Commissioner Brown**

Commissioner Brown said the timing is good to start brainstorming on what the Commissioners should start to do with the marijuana funds. He went over and discussed the MEMO he sent out. \*\*document is attached\*\*

They did not specifically define what the plans were for the money. Now they are in a position, with 3 months of collections, to figure out what to do. County receives 50%, state 5% and the rest is distributed to the cities based on population. He said that is a very rough estimate. As of today, there are no dollars in the bank, but he said it's a good time to start thinking about it.

Behavior Health Safety Net Workers Proposal discussed.

If people have questions, Commissioner Brown would be happy to answer them.

Anthea said this is good information for the strategic planning process and wanted to know when the Commissioners would figure out how and when to use it.

Commissioner Brown said they've had the same conversation with Behavior Health, and he would say the same thing to this council. We would really value input and proposals from the LAC.

Tom suggested the group define what their needs are and where we want to be. He said the LAC needs to figure out what the community needs and provide those services.

Ellie acknowledged that the strategic plan right now is to "get the house in order" and if that takes a year, the LAC will miss out on funding. We need to be aware of the new

things that are available and not think about what we did 24 years ago. We need to know what the new rules are.

Erin is tabling this discussion

Ben is with Greater Gallatin United Way and looks forward to joining in a more formal way.

Erin said the vote in position for 1 month, until the bylaws are updated.

Sophia Fortunato said August 14 her AmeriCorps Vista is up. She can really help with the strategic plan.
